IN TOTAL, THE MUSEUM SERVED 180,844 VISITORS THIS YEAR, AND A MEMBERSHIP OF NEARLY 8,000 HOUSEHOLDS. APPROXIMATELY 90% OF THE MUSEUM'S VISITORS ARE RESIDENTS OF THE SAN FRANCISCO BAY AREA, WITH 53% IDENTIFYING AS PEOPLE OF COLOR. 50% OF VISITORS EXPERIENCED OMCA AT A FREE OR DISCOUNTED RATE.
